**MEMORANDUM**

The State Government has decided to implement the NFS Act, 2013 in the State from 1<sup>st</sup> September 2015. Accordingly, category-wise revised scale & price of foodgrains from the month of September 2015 will be as follows:

Sl	Name of Commodities	Monthly Entitlement	Existing Retail Issue Price at FPS Level (Rs. / per Kg.)	Revised Retail Issue Price at FPS Level w.e.f 01-09-2015 (Rs. / per Kg.)
i	Rice for AAY ration cards (households)	35 Kgs. per card/family	2.00/-	2.00/-
ii	Rice for Priority Households	05 Kgs. per head	2.00/-	2.00/-
iii	Rice for APL R/C (households)	05 Kgs. per head subject to maximum 15 Kgs per ration card	10.35/-	13.00/-
iv	Wholemeal Atta for all category of ration cards	01 Kgs. per head	10.00/-	13.00/-

2. Scale & Retail Issue Price of other PDS Commodities (Iodised Salt, Sugar & K. Oil) will remain unchanged.

3. As per decision of the State Government, Doorstep Delivery (positioning of rice at FPS level from State Food Godowns) for **Rice** under all categories will be introduced from the month of September 2015 through Transport Contractors as appointed by the concerned SDMs.

4. Dealers Commission (DC) for distribution of **Rice under NFSA & APL category** has been revised @ Rs. 143.00 per quintal. DC for other PDS commodities shall remain unchanged.


5. As per directives of the Central Government, on-line F.P. Shop wise allocation of rice under NFSA (AAY&PG) is being generated by using Common Application Software (CAS) developed by the NIC. Therefore, DOs for AAY & PG Rice would be issued only as per FP Shop-wise quantity mentioned in the On-line allocation generated for the

month of September 2015. In respect of other commodities, existing system of calculating F.P. Shop-wise allocation shall continue for the present.

6. All DO Issuing Authorities of the State are requested to issue Delivery Orders (DOs) as per above scale & price from 1<sup>st</sup> September 2015 after deducting applicable rate of Dealers Commission..


