



**MEMORANDUM**

Sub-Division wise sub-allocation of **Atta, Flour & Suji** from the Roller Flour Mill, Agartala for distribution amongst the ration cardholders @ Rs. 13.00 per kg under PDS is hereby made as the '**Special Festival Quota**' in connection with ensuing 'Durga Puja' Festival during the month of October 2018 as per quantity mentioned below.

3. Atta, Suji & Flour allocated for **Jirania, Bishalgarh, Amarpur, Sonamura, Udaipur, Jampuijala, Karbook, Panisagar, Kanchanpur & Dharmanagar** will be lifted by Departmental Trucks from the respective Flour Mills and to be positioned at respective Food Godowns as per the requisition received from the Sub-Divisions. For these Sub-Divisions, F.P. Shop dealers shall deposit the cost of Atta/Suji/Flour @ Rs. 1157/- per qtl. (excluding the DC of Rs. 143 per qtl) in advance in favour of the Director, FSC&CA through Special Challan No. 21 at the respective SDM offices as like as existing procedure for depositing cost of PDS rice. On receipt of deposit from the F.P. Shop dealers, SDM shall compile godown wise requirement and send the requisition to the undersigned along with 01 (one) copy of Deposit Challan. Thereafter, on receipt of requisition from the Sub-Divisions, Departmental trucks will be placed for transportation of Atta to the respective Food Godowns from the Flour Mills. Sub-divisional Nominees will not be allowed to involve in carrying & distribution process for these Sub-Divisions. Detail administrative order in this respect issued vide Memo of even no. dated 05.07.2013 and concerned SDMs are requested to act accordingly.

4. Doorstep Delivery should be ensured for positioning of Atta/Suji/Flour to the FP Shops by the transporters engaged in the Sub-Divisions, where stock is positioned at State Food Godowns. In case of Sub-Divisions, where Sub-Divisional Nominees/FP Shops Dealers are lifting the stock from RF Mills, utmost initiatives should also be taken for ensure doorstep delivery and in case, doorstep delivery is not possible due to administrative complexities, FPS Delaers shall lift the stock from the Godowns of the Sub-Divisional Nominees/RF Mills. In that case, FPS Delaers shall be entitled to get TC at par with tendered doorstep delivery rate finalized for transportation of Rice within a particular Zone and FPS Delaers shall submit applicable TC claims as per prevailing procedure. Issue price of Atta/Suji Flour by the Sub-Divisional Nominees shall also be Rs. 1157/- per qtl.

5. Scale of distribution of commodities amongst the cardholders shall be as follows:

- Atta = 01 /head for all ration cardholders
- Flour = 02 kg/ration card for all ration cardholders
- Suji = 500 gm/ration card for AAY& PHH ration cardholders.

**6. Last date of lifting of commodities by the F.P. Shop Dealers is 10.10.2018 and delivery to the cardholders should be made during the month of October, 2018 & to be continued up to 10.11.2018 (upto Dipavali Festival).**

**7. Delivery Orders (D.O.) for this allocation are to be generated manually through Special Challan Form No. 21, as per requirement of respective F.P. Shops.**

8. Wheat Bran produced by the R.F. Mills against the allocation of Wheat made against this festival allocation shall be sold to the ARD Deptt/Agartala Diary or other Govt. Organizations @ Rs. 1157/- per qtl. by the RF Mills, only after receipt of release order from this Directorate.
