**Auction Notice for Unserviceable and Rotten empty Jute/Gunny Bags kept in different Govt. Food Godowns under Belonia Sub Division, South Tripura District**

The undersigned for and on behalf of the Governor of Tripura invites offer of rate/(s) from intending Tenderer/ purchaser of Indian national having financial resources for purchase of **un-serviceable empty jute gunny bags and rotten jute/gunny bags mentioned in the Table herein below** against the following Govt. Food Godown/(s) under Belonia Sub-Division 01.11.2015 to 31.08.2020 under the **Terms & Conditions** as narrated herein below:-

**The following Terms & Conditions should be followed by each and every intending purchasers:-**

1. The intending Tenderer / purchaser(s) shall have to quote /offer of rate in words as well as in figure for the whole quantity of un-serviceable jute / gunny bags and Rotten jute / gunny bags (separately) as mentioned in the Table above **showing per bag rate** for purchase of the same. No piecemeal offer is acceptable.
2. A sum of **Rs. 5,000/- ( Rupees Five thousand )** only shall have to be deposited by the intending purchaser/(s) as **EARNEST MONEY DEPOSIT (EMD)** in the form of DEMAND DRAFT in favour of " *The Sub-Divisional Magistrate, Belonia, South Tripura*" which shall be valid for a period of **6(six) months** from the last date of receipt of the Auction Notice and it shall be obtained from any scheduled Bank guaranteed by the RBI. The DD shall have to be **enclosed in original** with the offer of rate failing which the offer shall be treated as a invalid one.
3. The intending Tenderer/purchaser(s) may visit/examine the stock of above mentioned empty jute/gunny bags in the concerned Govt. Food Godowns during office hour on all working days up to **10 (ten) working days from the date of publication of this Auction Notice** and the intending purchaser(s) shall have to furnish a certificate/statement dully signed by him/her compulsorily along with the offer of

rate in the manner that he/she has carefully examined for stock of unserviceable empty jute/gunny bags and rotten jute/gunny bags as kept for disposal in the concerned Govt. Food Godowns as mentioned in the Table above.

4. The intending Tenderer/ purchaser(s) shall submit his/her offer of rates (separately for unserviceable empty gunny bags and rotten gunny bags) by **16 -10-2020** in the office of the undersigned (Food Section) **upto 3.00 PM** in original in sealed cover with his/her full signature/full postal address/Mobile No. etc. No email/WhatsApp copy shall be entertained.
5. The intending Tenderer/purchaser(s) shall have to enclose **photocopies** of the following documents dully attested by any Gazetted officer of the Govt. or by self attested with the offer of rates:
  - a. **Nationality Certificate/PRTC of intending purchaser.**
  - b. **Up-to-date Professional Tax Clearance certificate.**
  - c. **Aadhaar Card.**
  - d. **Voter EPIC.**
  - e. **PAN card**
6. The Tenderers/purchaser(s) shall have to enclose a certificate/declaration dully signed by him in the manner that he/she has gone through the Terms & Conditions of this Auction Notice very carefully & agreed to abide by those Terms & Conditions accordingly.
7. The successful Tenderer/purchaser(s) have to deposit the value of un-serviceable empty jute/gunny bags and rotten jute/gunny bags at a time through **Special Challan Form No. 21 in C/D Account No. 8050051100468** (meant for **Rice / Wheat under Cash Credit System**) maintained with **Tripura Gramin Bank, Belonia Branch** in favour of the Director, Food, Civil Supplies & Consumer Affairs, Tripura within **7(Seven) days** on receipt of communication of acceptance of his/her offer of rate failing which the Earnest Money Deposit (EMD) as deposited by the purchaser(s) shall be forfeited by the Government of Tripura without assigning any reason.
8. On receipt of the deposit of value of the said Un-Serviceable empty jute/gunny bags and rotten jute/gunny bags, as mentioned above, the order for delivery of the stock shall be issued. The successful purchaser(s) shall have to arrange to receive and removal of such bags as mentioned above from the concerned Govt. Food Godown(s) within **15(Fifteen) days from receipt of the supply/delivery order, as the case may be, at his own cost and arrangement with additional 05 (five) days as ultimate period which may be considered for sanction by the undersigned in case of receipt of a written approach/prayer by the purchaser at least within 10<sup>th</sup> day out of stipulated 15 days with a valid and reasonable ground.** If the reason is not found suitable, the prayer for additional 5 (five) days may be turned down by the undersigned. In case of failure of successful purchaser (s) to receive / removal the entire stock of such bags offered for disposal through this Auction, the amount so deposited shall be forfeited by the Government and in the event, if the Government arrange such removal and dumping of the stock or disposal otherwise (against which the purchaser shall have no further claim), the related cost in that event shall be

realized from the Earnest Money Deposit (EMD) as deposited by the purchaser(s). If the amount of expenditure in the above event is not found within the Earnest Money deposit, the balance amount will be realized as land revenue on institution of certificate case against the purchaser.

9. The supply of the number of un-serviceable and rotten empty Jute / gunny bags mentioned above may increase or decrease at the discretion of the Sub-Divisional Magistrate, Belonia.
10. No conditional offer of rate or partial offer of rate, as the case may be, shall be accepted.
11. The reserve value of each **un-serviceable empty 50 kgs Jute/gunny bags is Rs.3.00 (Rupees Three) per bag and** reserve value of each **rotten Jute/gunny bags is Rs. 1.50**. The Tenderer/bidder/auctioneer shall must have to quote their tender price/value beyond/higher than reserve values in all cases. No tenderer/bidder/quotationer shall be entertained lesser than the reserve price as fixed by the authority.
12. The offer will be received up to **3.00 (Three) PM on 16 -10-2020** and shall be opened at **3.30 (Three thirty) p.m.** on the same day, if possible and purchaser himself / herself or authorized representative of purchaser(s) [not more than one representative in favour of one purchaser] may remain present at the time of opening of the offer.
13. The intending Tenderer/ purchaser(s) shall be responsible to abide by all the Terms and Conditions as laid down in the Auction Notice.
14. Authority shall have the right to postpone or reject the submitted offer of rates in case of non-receipt of desired rate or any other reason etc. However, in the interest of positioning /storing of PDS items in afore-said Govt. Food Godowns, authority shall have the right for sequential negotiation with all the intending purchaser(s) as would be found eligible.
15. The intending Tenderer/ purchaser(s) shall drop the offer of rate along with relevant required documents as stated above either personally or through his/her authorized representative in the **Auction Box/ Tender Box**, as the case may be, which shall be kept in the office of the undersigned from **upto 3.00 PM on 16-10-2020** and in no circumstances offer of rate shall be accepted after expiry of the scheduled date & time i.e. **on 16 -10-2020**,
16. All documents relating to the Auction Notice shall be in English language only. Wheresoever, the intending purchaser(s) is intended to submit his/her offer of rate in other language, he/she has to get a translation of the said documents from Notary Public or designated authority and also to submit the same along with the original one.
17. Any offer which does not comply with any of the terms & conditions of this Auction Notice shall stand invalid.
18. The undersigned reserves the right either to accept or reject any offer of rate as offered including the highest one without assigning any reason thereof.
